COMMUNICATION OF PURCHASE TREASURY SHARES

Rome, 03 October 2023 - CY4GATE (CY4.MI) - a group operating in the all-encompassing cyber security and cyber intelligence market - as part of the treasury share buyback program communicated to the market on 27 April 2023 and launched on 08 August 2023, announces that it has purchased on the Euronext Milan Market – STAR Segment in the period between 01 September 2023 and 30 September 2023 inclusive, a total of no. 47,157 treasury shares (corresponding to approximately 0.20% of the share capital), at an average price equal to about € 8.20 and for a total value of € 386,746.19.

Based on the information provided by Equita SIM S.p.A, the authorized intermediary in charge of carrying out the purchases covered by this press release, the summary of the transactions is shown below, on a daily basis, in aggregate form:
