COMMUNICATION OF PURCHASE TREASURY SHARES

Rome, 03 January 2024 - CY4GATE (CY4.MI) - a group operating in the all-encompassing cyber security and cyber intelligence market - as part of the treasury share buyback program communicated to the market on 27 April 2023 and launched on 08 August 2023, announces that it has purchased on the Euronext Milan Market − STAR Segment in the period between 01 December 2023 and 31 December 2023 inclusive, a total of no. 28,012 treasury shares (corresponding to approximately 0.12% of the share capital), at an average price equal to about € 7.88 and for a total value of € 220,844.70.
