COMMUNICATION OF PURCHASE TREASURY SHARES

Rome, 01 February 2024 - CY4GATE (CY4.MI) - a national and European player in cyber security and cyber intelligence - as part of the treasury share buyback program communicated to the market on 27 April 2023 and launched on 08 August 2023, announces that it has purchased on the Euronext Milan Market – STAR Segment in the period between 02 January 2024 and 31 January 2024 inclusive, a total of no. 50,284 treasury shares (corresponding to approximately 0.21% of the share capital), at an average price equal to about € 7.68 and for a total value of € 384,717.92.

Based on the information provided by Equita SIM S.p.A, the authorized intermediary in charge of carrying out the purchases covered by this press release, the summary of the transactions is shown below, on a daily basis, in aggregate form:
