**CY4GATE AWARDED CONTRACTS WITH A TOTAL VALUE  
OF APPROXIMATELY € 2.0 MILLION FOR DECISION INTELLIGENCE AND CYBER SECURITY

Rome, 16 April 2025 - **CY4GATE (CY4.MI)**, national and European player in cyber security and cyber intelligence, has signed contracts worth a total of approximately € 2.0 million for decision intelligence and cyber security solutions for institutional and corporate customers in Italy (70%) and abroad (30%) for a period of one year.

The recently signed contracts concern the supply of latest-generation technological solutions developed by the CY4GATE Group in the areas of Decision Intelligence and Cyber Security, sectors in which the Group continues to strengthen its leading role both in Italy and in Europe.
