



IN THE PAST THREE WEEKS CY4GATE HAS BEEN AWARDED NEW 1-YEAR CONTRACTS WITH IMPORTANT CORPORATE CUSTOMERS IN THE CYBER SECURITY SECTOR FOR A TOTAL VALUE OF APPROXIMATELY €500,000

Rome, 11 October 2022 – **CY4GATE GROUP** (EGM: CY4) - a company that operates at 360° in the cyber security market, informs that it has been awarded new contracts for the supply of its modern SIEM RTA and for its customization and integration with OT/Scada systems for the protection of critical plants particularly vulnerable to cyberattacks. The total value of the contracts is approximately €500,000 and they have been stipulated for 1 year.

The object of the contracts is the supply of Cy4gate licences for modern SIEM RTA to be installed on customer SOC and customized in an industrial context in which Operation Technologies (OT) require dedicated protection from cyberattacks in order to ensure business continuity. These are systems that are not secured by design and were not expected to have to interface with other systems to exchange data. The advanced RTA technologies allow to identify in real time, even at an OT level, any "abnormal" behaviour and display it on a dedicated dashboard controlled by expert personnel, with the aim of preventing and/or quashing potential cyberattacks.

The acquired contacts, particularly the OT protection project, will give the team in the Engineering department the opportunity to focus on cyber security frontier technology and will also see the involvement of the Cy4Gate Artificial Intelligence Competence Centre in fine-tuning the use of artificial intelligence algorithms in new complex contexts, increasing further product versatility in fields that range from Information to Operations Technology, strengthening cyber competencies on a national and European level.

Emanuele Galtieri, CEO and General Manager of Cy4gate Group, said "Thanks to these new successes, Cy4Gate continues its growth and consolidation process offering added value products and services for the complex Cybersecurity market. Protection from cyberattacks, which have become increasingly more unpredictable both in terms of timing and methods, is a key factor in ensuring the smooth and uninterrupted flow of activities in our society: today, the level of actual and perceived insecurity in this area is extremely high. The trend can be inverted only by divulging an adequate level of awareness and training on the sensitive topics of cyber security and by acquiring, as a country and across Europe, expertise and state-of-the-art technology.
