# CY4GATE HAS AWARDED TWO CONTRACTS FOR THE SUPPLY OF "SENTRY", A CYBERSECURITY PRODUCT, FOR THE BENEFIT OF A PRIMARY NATIONAL INSTITUTION

### THE PROJECTS, WITH A DURATION OF 12 MONTHS, HAVE A TOTAL VALUE OF €1.25 MILLIONS

Rome, 29 December 2023 - CY4GATE (CY4.MI), a national and European player in cyber security and cyber intelligence, announces that it has signed two contracts for the supply of proprietary cybersecurity technologies; this is the product called "SENTRY", completely created by the company.

The contracts, with a total worth of €1.25 millions and for a duration of one year, use the most recent technologies and algorithms resulting from many years of internal investments in Research and Development, with the aim of identifying complex and selective cyberattacks which, through access unauthorized, they are capable of taking confidential data or causing damage to the target. These are the so-called "advanced persistent threats" or "Advanced Persistant Threats" (APTs).

The acquisition of this new contract confirms the validity of the company's choice to integrate into its offering an advanced system for detecting the most subtle cyber threats, namely APTs, which in the last year have proven to be particularly insidious and capable of generating significant damage to affected devices.

The company continues to strengthen the cyber security segment and in 2024 will be able to count on a portfolio of high-level technologies that further enrich the customer value proposition in cyber security thanks to:

- **modern SIEM "RTA"**, for the detection of anomalous behavior and therefore potential attacks on networks, equipped with advanced alerting systems and the possibility of activating increasing levels of automation in the response to the attack;
- **SENTRY**, a unique product of its kind which thanks to innovative proprietary techniques promptly identifies cyberattacks carried out with advanced techniques that make malware persistent in target systems;
- **Cyber Digital Twin**, technology capable of reproducing a computer network of a company or public body in order to allow realistic training for cyber security operators, simulate attack scenarios to verify the robustness of the networks and use it as a tool for preventive testing of new technologies before their integration into the real network;
- **SMASH®** platform (Smart Anti-fraud shield), which is based on Artificial Intelligence to carry out behavioral analysis of the end user and protect him from potential fraud in online banking operations and digital payment services. SMASH is able to ensure protection for both web and mobile channels, combining the analysis of behavioral biometric data with multi-factor authentication. SMASH has become part of the new product catalog following the recent preliminary signing for the acquisition of the Italian company XTN. The product will allow the Group to enter new markets such as banking, gambling and automotive.
