IN THE LAST TWO MONTHS OF 2021, CY4GATE ACQUIRES SEVERAL ONE-YEAR CYBER SECURITY CONTRACTS WITH TOP CORPORATE CLIENTS WORTH A TOTAL OF OVER €500,000

Rome, 23 December 2021 - CY4GATE (EGM: CY4) - a company active in all areas of the cyber market, announces that top Italian companies in the high-tech, telco and media & events sectors have awarded it contracts for the provision of ICT analysis and redesign services to upgrade their proprietary ICT infrastructures to meet higher cyber resilience standards in the fight against potential cyber attacks.
