Rome, 16 September 2021 - **CY4GATE** (AIM: - a company active in all areas of the cyber market - announces that it is taking part in a major European program financed by a leading European Cyber Defence Agency, which will equip the partners with an advanced, innovative capacity to combat looming and persistent cyber threats. This is one of the European Defence Fund (EDF) projects to render EU member states autonomous in the defence sector and promote military cooperation between members.

Worth over €300,000, the project will significantly expand CY4GATE's technologies and know-how in this specific segment. The project will enable the company to apply its proprietary technologies in the RTA (real time analytics) and QUIPO (decision intelligence) product family, making major improvements by harnessing sophisticated artificial intelligence, machine learning and cognitive computing techniques capable of preventing and countering new generation cyber attacks.
