

NOTIFICATION OF SUBSTANTIAL CHANGE IN OWNERSHIP AXA INVESTMENT MANAGERS S.A.'S INTEREST IN CY4GATE INCREASES TO 5.29%

Rome, 11 December 2020 - It is announced that on 10 December 2020, CY4GATE (AIM: CY4) received notification from AXA Investment Managers S.A., based at Tour Majunga - 6, Place de la Pyramide - 92908 Paris, of a substantial change in ownership pursuant to Article 17 of the AIM Italia Issuers Regulation, in which it informed the Company, in accordance with Article 12 of the Articles of Association, that on 4 December 2020 its investment in CY4GATE had reached the relevant threshold of 5.29% of share capital consisting of voting rights shares.

As a result of this change, the following shareholders own an investment of at least 5% (i.e., "significant shareholders") in the Company:
